



Rowdy Girl Sanctuary Release of Claims, Waiver of Liability, Photographic Release and Consent Agreement

In consideration of my attendance at the Rowdy Girl Sanctuary, Inc. ("Rowdy Girl") TOUR (the "Event"), I hereby voluntarily and knowingly acknowledge and agree, on my behalf and on behalf of my heirs, administrators, executors, and assigns to hold harmless Rowdy Girl Sanctuary and, in their official and individual/personal capacities, Rowdy Girls' officers, directors, employees, representatives, volunteers, event agents and vendors, sponsors, insurers or other agents (together, the "Rowdy Girl Parties"), from and against any and all losses, costs, expenses, liabilities, claims, injuries and/or damages, (collectively, "Damages") that I may incur directly or indirectly arising out of or related to my attendance at the Event.

I hereby waive, release, and discharge any and all claims for Damages whatsoever to me or to my property, which may be caused by Rowdy Girl Parties, or otherwise result from my participation in or attendance at the Event.

I hereby assume any and all risks associated with attending this Tour, including but not limited to, any falls, contacts with other participants, animals and fixed and/or non-fixed objects, the effects of weather, and conditions on the property where the Event is taking place including, without limitations, conditions of all walkways and roads, all such risks being known and appreciated by me or otherwise not of a concern to me.

I hereby grant the Rowdy Girl Parties and their respective successors and assigns, the unrestricted and irrevocable right to use for any purpose and without compensation and/or further notice both my name and likeness by whatsoever means reproduced, including but not limited to recorded, videotaped, or photographed in any medium or by any manner whatsoever in connection with any promotion, campaign, or other activity in which any of Rowdy Girl Parties may lawfully engage.

If I am accompanied by any of my children or other minors in my care at the Event, I acknowledge I am also signing this Release in my capacity as their Parent, Caregiver and/or Legal Guardian, and that the terms of this Release shall also cover my children or other minors in my care.

The above indemnities, release and waivers are intended to be enforceable in accordance with their express terms notwithstanding Texas' express negligence rule or any similar directive that would prohibit or limit them because of the simple or gross negligence or other fault or strict liability of the Rowdy Girl Parties.

I ACKNOWLEDGE THAT THE INDEMNITIES, RELEASES AND WAIVERS ABOVE MAY RESULT IN INDEMNIFICATION, RELEASE OR WAIVER IN FAVOR OF ANY OF THE ROWDY GIRL PARTIES FOR HIS, HER OR ITS SIMPLE OR GROSS NEGLIGENCE (WHETHER SOLE, CONCURRENT, ACTIVE OR PASSIVE) OR OTHER FAULT OR STRICT LIABILITY.

I ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS RELEASE, AND FULLY UNDERSTAND ITS TERMS. I UNDERSTAND THAT, BY ACCEPTING THIS RELEASE, I HAVE GIVEN UP SUBSTANTIAL RIGHTS. I ACCEPT THIS RELEASE FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, AND/OR GUARANTEE BEING MADE TO ME.
