1 Briefly describe the organization's mission: RGS provides sanctuary to farm animals at risk of being slaughtered and promotes an ethical vegan lifestyle. RGS seeks to educate the public on plant-based food options, FFA/4H, factory farming practices, and the devastating impact of animal agriculture on the environment.

4a (Code:) (Expenses \$ 168,888. including grants of \$ 50.) (Revenue \$) Farm Animal Sanctuary - provides sanctuary and lifelong care to 121 rescued farm animals. In 2022, RGS rescued 14 farm animals.

4b (Code:) (Expenses \$ 96,479. including grants of \$) (Revenue \$ 10,000.) The Rancher Advocacy Program (RAP) aims to offer support and viable solutions to ranchers to transition to plant-based agriculture. Ranchers and their families sometimes face the fact that due to emotional, environmental, ethical, social, or financial conflicts, they need a path to keep their land but move away from utilizing animals for profit. We value the process of becoming their allies from the beginning and supporting their efforts throughout the entire process of transitioning to sustainable agriculture. Shifting to plant-based agriculture allows them peace of mind while impacting the consumers, animals, and our planet.

4c (Code:) (Expenses \$ 5,961. including grants of \$) (Revenue \$) Families Choosing Compassion (FCC) program brings families of children together that participate in Future Farmers of America and 4-H school projects of raising farm animals, saddened by the result that leads to the slaughter of the animals raised as school projects. We are not an antagonist but rather a substitute and haven for children and families that can't remain desensitized to the "food" animal structure prevalent in our education systems. We aim to instill a deeper awareness and appreciation of farm animals as unique individuals worthy of our love and respect.
