RGS educates the public about plant-based food options, FFA/4-H, factory farming practices, and the devastating environmental impact of animal agriculture.

In 2025, Rowdy Girl Sanctuary rescued 17 farmed animals. We continue to provide knowledge and resources for other sanctuaries to succeed in their work.

4b (Code:) (Expenses \$ 61,008. including grants of \$) (Revenue \$) Rowdy Girl Sanctuary educates the public by telling our unique story about the transformation of a former cattle ranch. Through tours, our social media network, media placement, and speaking engagements, we educate the public about the benefits of a plant-based diet, the environmental impact of animal agriculture, and how our food system works. We also have special events inviting experts in various fields of study to speak about plant-based diets, the environment, and animal ethics. Rowdy Girl Sanctuary founder Renee King-Sonnen is invited to speak around the country and in many parts of the world. The Rowdy Girl documentary continues to be screened worldwide to broaden its educational reach.

4c (Code:) (Expenses \$ 2,944. including grants of \$) (Revenue \$) The Rancher Advocacy Program (RAP) is a global online resource and social media powerhouse dedicated to educating, motivating, and inspiring ranchers considering a shift away from animal agriculture.
